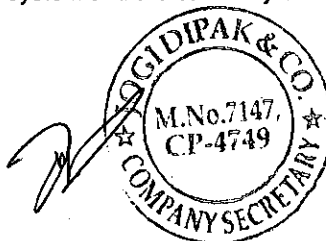
I, **Dipak Renukumar Jogi**, Practising Company Secretary, was appointed as Scrutinizer by the company for the purpose of scrutinizing the process of voting through electronic means ("e-voting") in terms of the provisions of Section 108 of the Companies Act, 2013 ('the Act') read with Rule 20 of the Companies (Management and Administration) Rules, 2014 ('the rules') as amended from time to time in a fair and transparent manner, for passing of the resolutions as mentioned under Ordinary Business - Item numbers 1 to 6 as set out in the notice dated 24th August, 2022 ("Notice") issued by the Company in accordance with Circular No. 14/2020 dated April 08, 2020, Circular No.17/2020 dated April 13, 2020 issued by the Ministry of Corporate Affairs followed by Circular No. 20/2020 dated May 05, 2020 and Circular No. 02/2021 dated January 13, 2021 and Circular No. 02/2022 dated 05th May, 2022 respectively, issued by Ministry of Corporate Affairs, Government of India (hereinafter referred to as "MCA Circulars"), convening the 74th AGM of its members through VC / OAVM on Wednesday, 29th September, 2022 at 05:00 P.M

The management of the Company is responsible to ensure the compliances with the requirements of the Act, the Rules made thereunder and MCA Circulars relating to Remote voting and e-voting during the AGM on the resolutions as set out in the Notice of AGM of the members of the Company. My responsibility as a Scrutinizer for the Remote e-voting and voting during the AGM is restricted to make a Consolidated Scrutinizer's Report of the votes cast 'in favour' or 'against' the resolutions stated in the said Notice, based on the reports generated from the e-voting system provided by National Securities Depository Ltd ("NSDL"), the agency engaged by the Company to provide Remote e-voting and e-voting during the AGM in a fair and transparent manner.

As per the confirmation received from the Company:

1. In terms of the notice convening the Annual General Meeting, voting period was kept open for 3 days commencing from Monday, 26TH SEPTEMBER, 2022 (09:00 am IST) and ends on Wednesday, 28TH SEPTEMBER, 2022 (05:00 pm IST).
2. The voting rights of members was considered in proportion to the shares held by them in the paid-up equity share capital of the Company as on the cut-off date i.e. WEDNESDAY, 14TH SEPTEMBER, 2022.
3. As required under the MCA Circulars, the Company had also provided e-voting facility during the AGM to the members attending the said meeting through VC / OA VM and who had not cast their vote earlier.
